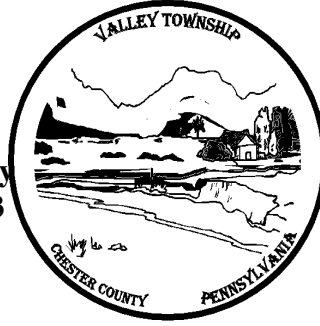

In accordance with Chapter 5, Section 10 of Valley Township Ordinance 95-3 all residents with an alarm system installed in their home or business are required to obtain a permit to install said system. Please enclose the \$25.00 fee for new installations. If you have an alarm system and have not obtained a permit to have the system installed please contact the Valley Township Bureau of Police. If you have a permit for your alarm system please check the renewal box on the application form. Please enclose a \$10.00 fee, which will be due annually for any alarm system.

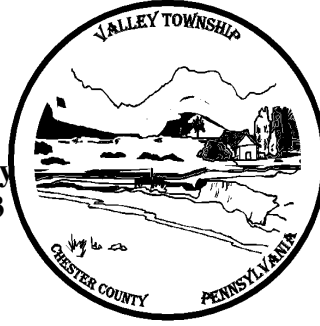

Pursuant to a permit issued or the continuance of the installation of any automatic protection device already installed, at the effective date of this chapter, shall constitute consent by the owner or lessee thereof, authorization for the inspection of any such installation and/or operation of any such automatic protection device by the Chief of Police or his authorized representative at a mutual agreed upon time, except in an emergency situation.
